

RESOLUTION NO. 14R-2441

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF SARASOTA, FLORIDA AMENDING THE BUDGET FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2013 BY PROVIDING FOR SUPPLEMENTAL APPROPRIATIONS IN THE AMOUNTS IDENTIFIED IN EXHIBIT A; PROVIDING FOR SEVERABILITY IF ANY OF THE PARTS HEREOF ARE DECLARED INVALID; PROVIDING FOR READING BY TITLE ONLY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to Resolution No. 13R-2370 the City has adopted a budget for the fiscal year beginning on October 1, 2013 and ending on September 30, 2014; and

WHEREAS, the City needs to amend said budget so as to provide for supplemental appropriations in the amounts identified in Exhibit A; and

WHEREAS, Section 166.241 (4) (c) Florida Statutes requires such a budget amendment be adopted in the same manner as the original budget.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF SARASOTA, FLORIDA:

Section 1. The budget for the fiscal year commencing October 1, 2013 is hereby amended by providing for supplemental appropriations in the amounts identified in Exhibit A.

Section 2. Should any section, sentence, clause, part or provision of this Resolution be declared invalid or unenforceable, by a court of competent jurisdiction, the same shall not affect the validity of this Resolution as a whole, or any part hereof other than the part declared to be invalid. Said provision declared to be invalid shall be deemed severed from the remaining provisions of this Resolution.

Section 3. Resolutions or parts of Resolutions in conflict herewith are hereby repealed to the extent of such conflict.

Section 4. This Resolution shall take effect immediately upon adoption.

ADOPTED by the City Commission of the City of Sarasota, upon reading by title only, after posting on the bulletin board at City Hall for at least three (3) days prior to adoption, as provided by Article IV, Section 2 of the Charter of the City of Sarasota, this 18th day of August, 2014.

**Subject:** Request for Budget Amendment from the Law Enforcement Trust Fund (110-070-000-000804-000000)

The Sarasota Police Department would like to provide donations to the following programs from the State LETF Fund, pursuant to the requirements of Florida Statute No. 932.7055(5)(c)(3):

**Roy McBean Boys and Girls Club:** Originally a satellite boy's club within the housing project, the Roy McBean Boys and Girls Club of Sarasota has a longstanding relationship with the Sarasota Police Department. The club's youth development strategy continues to emphasize drug and alcohol resistance, and by the club's mere existence helps make the neighborhood and its children safer. The McBean club's mission statement is "To inspire and enable all young people, especially those from disadvantaged circumstances, to realize their full potential as productive, responsible and caring citizens." They have had great success in attaining their goal. Requested donation amount: \$2,000.

**Sarasota Drug Free Youth Initiative ("SRQ DFy"):** DFy, as it is known encourages youth ages 12-18 to be drug, alcohol, and tobacco free. This program uses an evidence-based, environmental strategy to help reduce adolescent drug and alcohol abuse in Sarasota. This program has the following characteristics: helps parents acknowledge their child's choice to remain drug and alcohol free; rewards children at merchants they know with discounts when they present their card; requires kids to have fidelity to their commitment by random drug screening; as a community, praises and recognizes their smart choices, giving members a sense of pride and belonging; gives the member an ironclad defense against peer pressure when confronted by temptation; gives youth an opportunity to participate in Drug Free events of interest. Requested donation amount: \$1,000.

**Selah Freedom House of Sarasota:** Is a local organization which confronts the issue of sex trafficking and exploitation through advocacy, training and restorative services. Selah Freedom brings awareness to the issue of sex trafficking and provides a safe place for survivors to heal. The organization helps sexually exploited individuals find their voice and purpose and to reclaim all that was stolen from them through their victimization. Requested donation amount: \$2,500.

**First Step Alcohol and Drug Rehabilitation Center:** Helps individuals in our community to overcome alcohol and substance abuse issues. First Step works with people of all ages and walks of life. Their operations range from a 28-day intensive residential rehabilitation program, youth outpatient programs, to the mothers and infants program for pregnant, addicted women. First Step is a valuable resource in our community to proactively fight the effect of drug and alcohol abuse on the City's crime rates. Requested donation amount: \$2,500.

**Youth United for Success Mentoring Outreach Program:** At Trinity Youth and Family Services, Inc., the Youth United Program participants visit colleges and attend field trips to places such as St. Augustine, Florida, the first African American Business Community, the MLK Museum in Tennessee, and the MLK Center for Non-Violent Social Change in Atlanta, Georgia. The purpose of the Mentoring Outreach Program is to provide youth and young adults with the tools necessary to succeed in today's world. Participants learn how to better prepare for school, employment, relationships, and learn how to appropriately deal with peer pressure. They benefit from character education and guidance on substance abuse prevention. Requested donation amount: \$2,000.

**SPD's Crime Prevention Program:** The Crime Prevention Program encompasses many programs, of which here are a few: Neighborhood Watch, Business Watch, Project Lifesaver, SafeKids, Sarasota Summit for Safe Kids, and many others. A recent DOJ Publication stated that "The most effective law enforcement agencies recognize and promote partnerships with their citizens to prevent crime. Citizens who are engaged and empowered to be responsible for their communities are valuable assets to the work of any police department.

It is in this spirit that the Sarasota Police Department utilizes social media and websites as a platform for communication with neighborhood groups, keeping citizens informed about crime patterns in the City, reinforcing crime tips and awareness. The use of these platforms is proven to solve crime. As the popularity of social media rises, these tools provide opportunities for law enforcement agencies to proactively reach out and connect with citizens and promote crime prevention in their communities." Much of the funds requested for this program will be used to broadcast public service announcements to educate and communicate effective Crime Prevention tools to the City. Requested donation amount: \$6,000.

**Girls, Inc of Sarasota County:** As early as age 5, girls who attend Girls Incorporated of Sarasota County are exposed to life-changing education about entrepreneurship, technology, finances, engineering and science through national Girls Inc. curriculum and experiential learning through a girl-run city called "Dream Harbor." Eighty percent of those who participate move on to attend higher education and have successful careers. Girls Inc. offers affordable programs with lasting impact on young women in our community, with drug prevention, and drug education as part of the curriculum. Requested donation amount: \$2,000.

**S.P.A.R.C.C. (Safe Place and Rape Crisis Center):** SPARCC is the only state-certified center for domestic violence and sexual assault services for Sarasota and DeSoto Counties. All of SPARCC's services are free and confidential. In addition to serving victims, SPARCC is actively engaged in promoting social change through community awareness and education, in an effort to prevent such violence in the future. SPARCC serves its clients through an Outreach Center in downtown Sarasota, satellite offices in south Sarasota and DeSoto Counties, a shelter operating 24 hours a day/365 days a year and at the local courthouses. Requested donation amount: \$2,500.

**Sarasota Housing Authority Summer Program:**

The Housing Authority provides quality, affordable housing that enhances the lives of Sarasota residents and promotes independence. A donation is requested to assist in defraying the costs associated with the Housing Authority's Summer Enrichment Program involving career counseling services to youth. Requested donation amount: \$10,000.

**The Salvation Army:** Meets basic human needs by providing food, shelter, drug and alcohol abuse treatment, and financial assistance to those in need. Clients are assisted in seeking permanent answers to their crises. The Center of Hope provides food, shelter, and social services 365 days a year, serving 600-700 meals a day and housing more than 200 homeless families, women and men nightly. As well, the Salvation Army provides addition recovery programs on-site at the jail. Requested donation amount: \$1,500.

**Cal Ripkin, Sr, Badges for Baseball:**

The Badges for Baseball program builds rapport between police officers and at-risk youth. Using sports as a “hook” law enforcement officers teach a character education curriculum, *Healthy Choices, Healthy Children* through which youth are guided to make smart choices for their future. Through the relationships built in the Badges for Baseball program, youth can connect with positive role models and police officers can reach youth at a critical stage when they are beginning to make their own decisions. Requested donation amount: \$5,000.

The Sarasota Police Department views these particular programs as excellent examples of grass-roots crime prevention and drug abuse prevention education. Therefore, consider this memo as a request for a Budget Amendment for \$37,000 from the State Law Enforcement Trust Fund (110-070-000-000804-000000) in order to help defray operating costs for the above listed programs.

Further, as required by law, I certify to you that this request complies with the requirements of Florida Statute No. 932.7055(5)(c)(3) .

Dear Chief DiPino:

Congratulations on your recent award. In establishing financial assistance programs, Congress linked the receipt of federal funding to compliance with federal civil rights laws. The Office for Civil Rights (OCR), Office of Justice Programs (OJP), U.S. Department of Justice (DOJ) is responsible for ensuring that recipients of financial assistance from the OJP, the Office of Community Oriented Policing Services (COPS), and the Office on Violence Against Women (OVW) comply with the applicable federal civil rights laws. We at the OCR are available to help you and your organization meet the civil rights requirements that come with DOJ funding.

### **Ensuring Access to Federally Assisted Programs**

Federal laws that apply to recipients of financial assistance from the DOJ prohibit discrimination on the basis of race, color, national origin, religion, sex, or disability in funded programs or activities, not only in employment but also in the delivery of services or benefits. A federal law also prohibits recipients from discriminating on the basis of age in the delivery of services or benefits.

In March of 2013, President Obama signed the Violence Against Women Reauthorization Act of 2013. The statute amends the Violence Against Women Act of 1994 (VAWA) by including a nondiscrimination grant condition that prohibits discrimination based on actual or perceived race, color, national origin, religion, sex, disability, sexual orientation, or gender identity. The new nondiscrimination grant condition applies to certain programs funded after October 1, 2013. The OCR and the OVW have developed answers to some frequently asked questions about this provision to assist recipients of VAWA funds to understand their obligations. The Frequently Asked Questions are available at <http://ojp.gov/about/ocr/vawafaqs.htm>.

### **Enforcing Civil Rights Laws**

All recipients of federal financial assistance, regardless of the particular funding source, the amount of the grant award, or the number of employees in the workforce, are subject to prohibitions against unlawful discrimination. Accordingly, the OCR investigates recipients that are the subject of discrimination complaints from both individuals and groups. In addition, based on regulatory criteria, the OCR selects a number of recipients each year for compliance reviews, audits that require recipients to submit data showing that they are providing services equitably to all segments of their service population and that their employment practices meet equal opportunity standards.

### **Providing Services to Limited English Proficiency (LEP) Individuals**

In accordance with DOJ guidance pertaining to Title VI of the Civil Rights Act of 1964, 42 U.S.C. § 2000d, recipients of federal financial assistance must take reasonable steps to provide meaningful access to their programs and activities for persons with limited English proficiency (LEP). See U.S. Department of Justice, Guidance to Federal Financial Assistance Recipients Regarding Title VI Prohibition Against National Origin Discrimination Affecting Limited English Proficient Persons, 67 Fed. Reg. 41,455 (2002). For more information on the civil rights responsibilities that recipients have in providing language services to LEP individuals, please see the website <http://www.lep.gov>.

### **Ensuring Equal Treatment for Faith-Based Organizations**

The DOJ regulation, Equal Treatment for Faith-Based Organizations, 28 C.F.R. pt. 38, requires State Administering Agencies (SAAs) to treat faith-based organizations the same as any other applicant or recipient. The regulation prohibits SAAs from making awards or grant administration decisions on the basis of an organization's religious character or affiliation, religious name, or the religious composition of its board of directors.

The regulation also prohibits faith-based organizations from using financial assistance from the DOJ to fund inherently (or explicitly) religious activities. While faith-based organizations can engage in non-funded inherently religious activities, they must hold them separately from the program funded by the DOJ, and recipients cannot compel beneficiaries to participate in them. The Equal Treatment Regulation also makes clear that organizations participating in programs funded by the DOJ are not permitted to discriminate in the provision of services on the basis of a beneficiary's religion. For more information on the regulation, please see the OCR's website at [http://www.ojp.usdoj.gov/about/ocr/equal\\_fbo.htm](http://www.ojp.usdoj.gov/about/ocr/equal_fbo.htm).

SAAs and faith-based organizations should also note that the Omnibus Crime Control and Safe Streets Act (Safe Streets Act) of 1968, as amended, 42 U.S.C. § 3789d(c); the Victims of Crime Act of 1984, as amended, 42 U.S.C. § 10604(e); the Juvenile Justice and Delinquency Prevention Act of 1974, as amended, 42 U.S.C. § 5672(b); and VAWA, Pub. L. No. 113-4, sec. 3(b)(4), 127 Stat. 54, 61-62 (to be codified at 42 U.S.C. § 13925(b)(13)) contain prohibitions against discrimination on the basis of religion in employment. Despite these nondiscrimination provisions, the DOJ has concluded that it may construe the Religious Freedom Restoration Act (RFRA) on a case-by-case basis to permit some faith-based organizations to receive DOJ funds while taking into account religion when hiring staff, even if the statute that authorizes the funding program generally forbids recipients from considering religion in employment decisions. Please consult with the OCR if you have any questions about the regulation or the application of RFRA to the statutes that prohibit discrimination in employment.

### **Using Arrest and Conviction Records in Making Employment Decisions**

The OCR issued an advisory document for recipients on the proper use of arrest and conviction records in making hiring decisions. See Advisory for Recipients of Financial Assistance from the U.S. Department of Justice on the U.S. Equal Employment Opportunity Commission's Enforcement Guidance: Consideration of Arrest and Conviction Records in Employment Decisions Under Title VII of the Civil Rights Act of 1964 (June 2013), available at [http://www.ojp.usdoj.gov/about/ocr/pdfs/UseofConviction\\_Advisory.pdf](http://www.ojp.usdoj.gov/about/ocr/pdfs/UseofConviction_Advisory.pdf). Recipients should be mindful that the misuse of arrest or conviction records to screen either applicants for employment or employees for retention or promotion may have a disparate impact based on race or national origin, resulting in unlawful employment discrimination. In light of the Advisory, recipients should consult local counsel in reviewing their employment practices. If warranted, recipients should also incorporate an analysis of the use of arrest and conviction records in their Equal Employment Opportunity Plans (EEOPs) (see below).

### **Complying with the Safe Streets Act**

An organization that is a recipient of financial assistance subject to the nondiscrimination provisions of the Safe Streets Act, must meet two obligations: (1) complying with the federal regulation pertaining to the development of an EEOP (see 28 C.F.R. pt. 42, subpt. E) and (2) submitting to the OCR findings of discrimination (see 28 C.F.R. §§ 42.204(c), .205(c)(5)).

### Meeting the EEOP Requirement

If your organization has less than fifty employees or receives an award of less than \$25,000 or is a nonprofit organization, a medical institution, an educational institution, or an Indian tribe, then it is exempt from the EEOP requirement. To claim the exemption, your organization must complete and submit Section A of the Certification Form, which is available online at <http://www.ojp.usdoj.gov/about/ocr/pdfs/cert.pdf>.

If your organization is a government agency or private business and receives an award of \$25,000 or more, but less than \$500,000, and has fifty or more employees (counting both full- and part-time employees but excluding political appointees), then it has to prepare a Utilization Report (formerly called an EEOP Short Form), but it does not have to submit the report to the OCR for review. Instead, your organization has to maintain the Utilization Report on file and make it available for review on request. In addition, your organization has to complete Section B of the Certification Form and return it to the OCR. The Certification Form is available at <http://www.ojp.usdoj.gov/about/ocr/pdfs/cert.pdf>.

If your organization is a government agency or private business and has received an award for \$500,000 or more and has fifty or more employees (counting both full- and part-time employees but excluding political appointees), then it has to prepare a Utilization Report (formerly called an EEOP Short Form) and submit it to the OCR for review within sixty days from the date of this letter. For assistance in developing a Utilization Report, please consult the OCR's website at <http://www.ojp.usdoj.gov/about/ocr/eeop.htm>. In addition, your organization has to complete Section C of the Certification Form and return it to the OCR. The Certification Form is available at <http://www.ojp.usdoj.gov/about/ocr/pdfs/cert.pdf>.

To comply with the EEOP requirements, you may request technical assistance from an EEOP specialist at the OCR by telephone at (202) 307-0690, by TTY at (202) 307-2027, or by e-mail at [EEOSubmission@usdoj.gov](mailto:EEOSubmission@usdoj.gov).

### Meeting the Requirement to Submit Findings of Discrimination


If in the three years prior to the date of the grant award, your organization has received an adverse finding of discrimination based on race, color, national origin, religion, or sex, after a due-process hearing, from a state or federal court or from a state or federal administrative agency, your organization must send a copy of the finding to the OCR.

### Ensuring the Compliance of Subrecipients

SAAAs must have standard assurances to notify subrecipients of their civil rights obligations, written procedures to address discrimination complaints filed against subrecipients, methods to monitor subrecipients' compliance with civil rights requirements, and a program to train subrecipients on applicable civil rights laws. In addition, SAAAs must submit to the OCR every three years written Methods of Administration (MOA) that summarize the policies and procedures that they have implemented to ensure the civil rights compliance of subrecipients. The Edward Byrne Memorial Justice Assistance Grant Program (JAG) allows states and local governments to support a broad range of activities to prevent and control crime and to improve the criminal justice system, some of which could have environmental impacts. All recipients of JAG funding must assist BJA in complying with NEPA and other related federal environmental impact analyses requirements in the use of grant funds, whether the funds are used directly by the grantee or by a subgrantee or third party. Accordingly, prior to obligating funds for any of the specified activities, the grantee must first determine if any of the specified activities will be funded by the grant.
