**COA APPLICATIONS FOR DEMOLITION PERMITS, MOVING PERMITS, OR SIGN PERMITS FOR LOCALLY HISTORICALLY DESIGNATED STRUCTURES AND HISTORIC DESIGNATION APPLICATIONS** MUST BE SUBMITTED 28 DAYS PRIOR TO ANY SCHEDULED MEETING IN ORDER TO BE PLACED ON THE HISTORIC PRESERVATION BOARD AGENDA.

CITIZEN INPUT IS WELCOME DURING ALL HISTORIC PRESERVATION BOARD MEETINGS WITHOUT PRIOR NOTICE. CITIZENS MAY ADDRESS THE BOARD DURING PUBLIC HEARINGS AND TIME LIMITS ARE ESTABLISHED BY BOARD MEMBERS. CITIZENS MAY ALSO ADDRESS THE BOARD ON ANY TOPIC THAT IS NOT ALREADY ON THE AGENDA FOR A TOTAL OF 3 MINUTES.
